## 3. Domestic Abuse: Initial Response

- 3.1 JR provided a presentation of South Wales Police Public Service Centre (PSC). JR confirmed that there is an open invitation to PALG for anyone interested in attending the PSC to see how it is run. Anyone who wishes to attend should contact TL. **ACTION**
- 3.2 JR explained that the PSC is a single control room for South Wales Police and provided statistics on the yearly number of calls dealt with by the PSC. JR explained how the PSC utilises digital services such as social media and email for the public to report incidents.
- 3.3 JR explained that the PSC is the first point of contact for all incidents. JR provided an overview of the 2 main phases involved with the PSC: initial contact and dispatch. JR described the methods used by the public for initial contact including 999, live chat, 101, email and attendance in person.
- 3.4 JR provided an overview of the process that PSC follows to risk assess and grade incidents. JR explained how typical domestic violence cases are assessed and graded. JR described various structures in place that allow for scrutiny and oversight of the PSC function.
- 3.5 CR presented an overview of the control strategy used for Domestic Violence cases including communication, building rapport, and working with external partners to provide support. CR explained that recently there is a higher focus on methods to change and prevent perpetrators behaviour. CR invited members to comment on communication strategies South Wales Police can use with perpetrators.
- 3.6 The PALG attendees separated into breakout rooms to discuss the presentation and were invited to provide feedback.
- 3.7 The general feedback and recommendations from PALG included the need for South Wales Police to understand cultural competency to build community trust and engage with those who are averse to reporting to the Police. The group discussed the benefits of South Wales Police understanding the reasons why victims do not want to pursue cases and the importance of bringing in specialist support to victims / perpetrators at the earliest opportunity.
- 3.8 The group discussed the potential for perpetrators to use fear of reporting to their advantage and repercussions from other agencies such as Social Services. Queries were raised in relation to the benefits of over criminalisation of parents and the detrimental effect on children.

		<ul> <li>3.9 The group had discussions regarding the barriers for marginalised community reporting and the importance of working with victims / perpetrators even in cases of 'No Further Action'. The feedback highlighted the importance of Police Officers adopting a consistent approach and risk of Police Officer's experiencing fatigue and 'risk blindness'.</li> <li>3.10 The group discussed Kent Police's use of a 'rapid video response' (RVR) within Domestic Violence cases and the possibility of a similar mechanism being used by South Wales Police.</li> <li>3.11 The group discussed what South Wales Police is doing in relation to sexual abuse when the victim is from an ethnic minority background and the extensive campaign around 'Valerie's Law'. CR provided an overview of the current position of South Wales Police and focus on accurate</li> </ul>
